

HOWARD COLLEGE VOCATIONAL NURSING (VN) PROGRAM (BIG SPRING ONLY) VOCATIONAL NURSING ADMISSION REQUIREMENTS

Prior to actual admission in the Vocational Nursing Program, applicant must have successfully completed the required support courses with a final grade of “C” or above. If enrolled in these courses in the summer you must furnish proof of enrollment.

ADMISSION CRITERIA

It is the policy of Howard College not to discriminate on the basis of sex, race, color, religion, age, national origin, veteran, or qualified disability in educational programs, activities, admission, or employment policies.

All applicants to the Howard College Vocational Nursing Program who have met the requirements for admission to the college will be evaluated according to the criteria specified.

ADMISSION INFORMATION

Pre-Testing - Students seeking admission to the Vocational Nursing Program must take the Test of Essential Academic Skills Test (TEAS). The TEAS test can be taken once every 30 days. The maximum number of times the TEAS may be taken is three (3) in a year period. **Only TEAS scores will be accepted.** TEAS scores not taken at Howard College will be accepted from ATI that are mailed or emailed directly to the Howard College VN office. The TEAS test will be given at the testing center, (432) 264-5618. You will be responsible for registering and paying for the TEAS exam through the ATI website (www.atitesting.com).

Summer Terms - The summer will be a busy time for applicants **who have not** already taken or begun taking pre-requisite classes. During the summer terms, these students are required to take Anatomy & Physiology I & II, Life Span/Growth & Development, Microbiology, and Certified Nurse’s Aide. Students earning less than a final grade of “C” in non-nursing courses must repeat that course before becoming eligible to take Vocational Nursing courses. Students are also encouraged to register through Howard College to take the American Heart Association CPR for Health Care Providers. This course is required of all students accepted to the VN program.

BACKGROUND CHECK INFORMATION

In order to be considered as an applicant for the nursing program, the Texas Board of Nursing now requires all students to be fingerprinted and pass a DPS/FBI criminal background check prior to be accepted into a nursing program.

Within 2 – 3 weeks after application deadline (April 1), you will receive instructions from Howard College Nursing on how to schedule fingerprints to begin the Board of Nursing background check process.

After fingerprints have been completed and received by the Board of Nursing you will receive one of the following:

- 1) A blue card which indicates your background check is clear. This will need to be turned into the nursing department to complete your application folder.

OR

- 2) A letter from the Board of Nursing advising you to begin the Declaratory Order Process. This letter will need to be turned into the nursing department to complete your application folder.

***Students who have a positive criminal history or answer “YES” to any question on the application for licensure will be required to go through the declaratory order process. If the nature of the issue can be resolved within the delegated authority of the Operations Department, there will be no charge and the student will be sent an “outcome letter” stating that they will be allowed to take the NCLEX upon graduation. If the nature of the criminal issue is beyond the delegated authority of the Operations Department and must be transferred to the Enforcement Department for the review, the student will be billed the \$150 review fee. Only upon receipt of the fee will the file be transferred to the Enforcement Department for review. This process could take up to 4-6 months or longer.

If an applicant cannot present a “blue card” or “outcome letter” then they are not eligible to be accepted into the program.

Successful completion of a background check does not guarantee licensure or employment after graduation.

ADMISSION REQUIREMENTS/DEADLINE --- APRIL 1ST

New applicant folders are now kept in the respective Vocational Nursing Departments at San Angelo and Big Spring. Please submit application to the appropriate office based upon which campus you will be applying to.

1. Completed **Nursing** application form for admission into the Vocational Nursing Program.
2. Completed **Howard College** application form for admission into Howard College.
3. An **official** transcript from each college/university attended that shows proof of pre-requisite courses, sent to the Nursing Department. Please send transcript attention to Nursing Department.
4. Howard College transcripts the nursing department will run.
5. Results of the TEAS examination.
6. Placement of transfer students is dependent upon vacancies existing within established enrollment limits and the written approval of the Program Director.
7. Background check through **Castle Branch** completed:

8. Proof of at least 2 doses of the Hepatitis B series.
9. Proof of Certified Nurse's Aide (C N A).

Following completion of the admission requirements by the designated deadline of **April 1**, the applicant will be considered for the selection pool. **An applicant's file is not complete until all of the admission requirements have been submitted**, with the exception of the second summer semester pre-requisite classes.

Applicants are responsible for keeping their file updated with current addresses and phone numbers. Giving this information to the Admissions Office does not guarantee the Nursing Office will get it. A new application must be completed for each year you wish to be considered for admission.

Completion of a specific program will be affected by the student's ability to successfully complete the required clinical rotations. Clinical rotations are completed at sites specified by and contracted with Howard College. Howard College will not locate or provide alternative sites for clinical rotations for students ineligible to attend clinical rotations at the specified sites.

If accepted to the Vocational Nursing Program:

Prior to the first class day, students are required to have:

- a) A physical examination on the HC form (within previous three [3] months) showing ability to meet clinical requirements;
- b) The results of a PPD (within previous three [3] months);
- c) Proof of MMR immunization (a signed statement by medical practitioner showing 2 doses of vaccine or MMR titer level);
- d) TDAP vaccination (proof of within the previous 10 years);
- e) Hepatitis B vaccine series (three doses) or serologic proof of immunity to Hepatitis B;
- f) Two doses of Varicella vaccine or serologic proof of immunity to Varicella.
- g) Current CPR certification - American Heart Association-BLS (within past 12 month);
- h) Proof of health/hospitalization insurance by September 1 of year of admission.
- i) A current drug screen.

INSURANCE

Students enrolled in the Vocational Nursing Program are required to be covered by liability insurance prior to the beginning of clinical experiences and to maintain such insurance for the duration of their enrollment. A break in enrollment of either liability or health insurance will result in the student's inability to attend clinical. Arrangement to purchase liability insurance at a group rate will be made through the Howard College Business Office in conjunction with the payment of other required fees each semester you are enrolled in the VN Program.

Students are required to purchase health insurance at their own expense.

The Vocational Nursing program is a twelve (12) month Certificate Program that offers college credit. The Program is designed to prepare students to perform direct patient care under the supervision of a registered nurse and/or physician. Students are prepared for upward mobility in a nursing career. The program is approved by the Texas Board of Nursing and the Texas Higher Education Coordinating Board. Upon completion, students may make application to take the State Board Examination (NCLEX-PN) to become Licensed Vocational Nurses.

The Vocational Nursing program is a very intense program. Students that are interested in the program should be informed that good attendance is very important. The Board of Nursing requires a published attendance policy to be enforced by the Vocational Nursing Program. This attendance policy is one of both strict attendance in both theory classes and clinical. Students are not allowed to miss more than 32 clock hours per semester.

Fall & Spring Terms - Progression and admission to the fall term as a Vocational Nurse major is contingent upon successful completion of pre-requisite courses. A "C" or above is required in all nursing and support courses to progress to the next term.
